SECTION I: ORGANIZATIONAL OVERVIEW

Introduction

"Inclusion" and "equal participation" of every citizen are two vital characteristics of a well-functioning democratic society. With this realization, Ms. Sharmila Karki, along with her team including Ms. Meena Bista, Mr. Krishna Thapa, Ms. Shova Gautam, Mr. Himmat Singh Lekali, Ms. Sunita Chhatkuli, and Ms. Jyoti Paudel, founded Jagaran Nepal in 2002 AD (2058 BS) to advocate for women's equal participation with the vision to establish a just and peaceful society with gender equality. Thus, enhancing women's meaningful representation in political, cultural, social and economic spheres through policy advocacy, leadership development and capacity building has been the central agenda of Jagaran Nepal. The efforts of this organization, for the last 22 years, has revolved around this very agenda.

Historically, participation of Nepalese women in mainstream decision-making spaces has been minimal. The nominal presence and participation of Nepalese women in politics in early 2000s was the major driving force that encouraged Jagaran Nepal's founding team to establish this organization and initiate the 'WOMEN IN POLITICS' movement. When Jagaran Nepal was established, discussions about women's representation in politics were rare. In spite of facing challenges initially, from both public and political leadership, Jagaran Nepal was able to establish itself as a pioneer institution in advocating for this issue. Through persistent advocacy and lobbying, coupled with sustained efforts to empower and capacitate women; the agenda of improving women's political participation was gradually adopted by mainstream political parties and other contemporary organizations, making Jagaran Nepal's issues a national issue over time. Jagaran Nepal, alongside other women's rights organizations, played a crucial role in increasing women participation in decision-making processes in all spears of the society.

Jagaran Nepal remains dedicated to advancing the women's rights movement, particularly focusing on women's right to actively participate and make meaningful contribution in political and public spheres. Over the past two decades, significant progress has been made in women's rights, which would have been unimaginable 20 years ago. Jagaran Nepal is committed to continuing its efforts toward its vision while simultaneously addressing the evolving and complex issues faced by women in today's world order.

Thematic Areas of Work

1. Promoting Women's Equal and Meaningful Participation in Decision-Making Processes

Since its inception, Jagaran Nepal has been continuously advocating for women's meaningful representation in politics, local governance and other decision-making spaces of the society. Jagaran Nepal is a pioneer organization working for women's inclusion in politics and has continuously contributed to democratize governance. So far, the organization has been able to reach more than 25 districts of Nepal, including Karnali province, through partnership and collaboration with local organizations as well as various national and international development partners.

Jagaran Nepal under this thematic area has been continuously dedicated to initiate dialogues, organize forums, advocate, lobby and create pressure to spread awareness and institutionalize women's equal and meaningful participation. Additionally, leadership development of local women and capacity strengthening of elected women leaders has been a core program of the organization.

Jagaran Nepal has realized the need to further develop programs that focus on the capacity development of elected women representatives at all tiers of government so they can have more influence through their roles. Capacity strengthening packages which augments their current skills levels, builds confidence on technical issues of governance and contemporary issues, and orients them on their roles and responsibilities can provide women with more opportunities to participate and make significant contributions in decision making spaces.

The organization, in the past has worked with numerous local governments, namely Kailali Rural Municipality, Gauriganga Municipality, Panchadewal Binayak Municipality etc. with the intention to enhance the leadership abilities of women leaders and educate them on their rights and responsibilities as elected representatives.

2. Leadership and Skill Enhancement for Young Women

Jagaran Nepal, from its early days realized that merely advocating for women's rights was insufficient to achieve its vision. The organization's founders realized that developing future generations of women leaders is crucial to sustain the movement in order to achieve its goals. With this insight, the organization has prioritized the need to uplift young women across all tiers of society. To facilitate this, Jagaran Nepal focuses on empowering young women with leadership and entrepreneurial skills, helping them to embark on a journey outside of their homes and into various public roles within their communities.

Under this thematic area, the organization has been continuously coaching, educating, capacitating and empowering young women at the community level to become effective leaders. Additionally, it is equally important to provide young women with skills through which they can create value in society, helping them become financially independent while demonstrating their ability to contribute outside their homes.

Through programs implemented under this thematic area, numerous young women from various parts of the country have been able to uplift their socio-economic status. In several cases, women that have participated in Jagaran Nepal's trainings in the past have now become role models for other younger women in their community. Furthermore, these women now have taken the responsibility to train and empower other young women in their community. Many success stories of developing capable women leaders have been documented by Jagaran Nepal.

3. Economic Empowerment of Women trough Access to Resources

Jagaran Nepal has been developing and implementing programs that help to uplift the economic status of women to improve their livelihood. Under this thematic area, Jagaran Nepal has been continuously advocating for women's right to access various kinds of state and non-state resources while simultaneously promoting alternative mechanism like cooperatives to improve their economic access. Some of the identified resources that can be utilized to generate financial means for women include fair access to government budget, natural resources, access to market, productivity tools, alternative financing mechanisms etc.

As of now, just the identification of the available resources is not sufficient. Continuous support through knowledge dissemination on services and schemes, skill development trainings, counseling services, and education on ways to access such resources are vital. Through interventions that provide the aforementioned supplementary support, women can identify the resource sources, claim and utilize them in order to generate a sustainable financial avenue for their livelihoods.

As part of this program, Jagaran Nepal has implemented programs that provide skill development opportunities that impart technical as well as soft skills to women. Similarly, the organization has also implemented programs that sensitize women about the various kinds of resources they can access and has disseminated information on how to access, mobilize and utilize such resources for women's economic empowerment.

4. Women and Contemporary Issues (Climate Change, Environmental Degradation, Disasters, Food security etc.)

As an organization, Jagaran Nepal is acutely aware that women are at the forefront of receiving a disproportional burden in case of many contemporary global problems. Hence, Jagaran Nepal has been working to raise the concern of women along with other marginalized and vulnerable groups amidst the growing threats of climate change, environmental degradation, concerns of food security and frequently occurring disaster events that disproportionately impact the life and livelihoods of women as compared to men.

Women, particularly in developing countries, are more likely to be socioeconomic vulnerability as they often have less access to resources like land and financial services, making it harder for them to recover in case of such shocks. Additionally, women in this part of their world due to their traditional gender roles bear the responsibility for collecting water, firewood, and other essential resources, and environmental degradation and climate change makes such tasks difficult, increasing their workload. Moreover, women have limited involvement in decision-making processes, restricting their ability to respond to and recover from environmental disasters.

Jagaran Nepal's firmly believes that women's rights are interconnected with environmental and climate justice. We strongly believe that an organization that aims to promote women's rights should address such contemporary issues as women are at the forefront of bearing the adverse impact of such problems.

5. National and International Advocacy, Lobby and Campaign on Women's Political, Social, Cultural and Economic Rights:

Jagaran Nepal since its inception has continuously conducted advocacy and lobbying activities, awareness building campaigns and pressurized concerned authorities to raise all issues concerning women in collaboration with various networks, federations and respective stakeholder groups.

As part of the advocacy and lobbying efforts, the organization has conducted national dialogue on issues of women's meaningful participation and leadership, organized discourses with different political parties within the country, submitted multiple press releases to voice the demands of women on all issues pertaining to their rights, opportunities and livelihoods.

Furthermore, the organization has developed numerous Information, Communication and Education (ICE) materials as part of their programs for awareness building campaigns on women's issues and circulated them in almost 40 districts of Nepal. The goal of awareness campaign has mainly revolved around highlighting the significance of women's political participation and leadership in order to address other challenges that women face in their homes, communities and the nation as a whole.

SECTION II: Jagaran Nepal Activities for FY 2023-2024

22nd Annual General Meeting of Jagaran Nepal

Jagaran Nepal organized its 22nd Annual General Meeting (AGM) on 9th October, 2023 with the goal of sharing the organizations activities and progress for its twenty first year of operation. The meeting was also geared towards collecting feedback on the year's activities from the members and devising a road map from the upcoming year. The meeting was held in Jagaran Nepal's office premises in Kathmandu.

The 22nd Annual General Meeting was held under the chairmanship of chairperson Mrs. Samjana Pokharel along with the presence of the executive board members and technical advisors of the organization. Manisha Subedi who currently serves as the board member delivered the welcome speech and Shushila Shrestha; the current secretary facilitated the AGM.

The annual progress report and the annual financial report for the Fiscal Year 2022/23 was presented by secretary Mrs. Shushila Shrestha and treasurer Mrs. Leela Sharma respectively. These reports were passed to the executive board members and the technical advisors post correction through feedbacks from extensive discussions during the meeting.

Following the presentation by the secretary and the treasurer, chairperson Mrs. Samjhana Pokharel expressed great excitement on the organization having completed its 21 years of journey. She recalled

the struggles of the organization from its initial days and contemplated on the current scenario, where Jagaran Nepal has been able to establish itself as one of the prominent organization working in the area of women's right, their equal participation in decision making, politics and governance system.

The major topics that were discussed during the meeting were: major organizational achievements, challenges faced and lessons learnt from the last fiscal year and ways forward for the organization to sustainably keep working for social welfare.

The AGM also decided to appoint new auditor Mr. Man Bahadur Lamichhane for the fiscal year 2080/81. As every year, this year's AGM also ratified the decision of membership extension of the organization to the Social Welfare Council and other institutions, organizations and network that Jagaran Nepal is a part of. Another important decision taken during the AGM was to provide memberships to new people, especially young people working as a volunteer in the organization for some years. The Annual General Meeting ended with the commitment to achieve the organization's goals and objectives and fulfill its commitment to creating a just and peaceful society with gender equality.

Pre COP-28 Preparation: National Civil Society Consultation on Climate Justice

On 20th November, 2023 - Rural Reconstruction Nepal (RRN) in partnership with South Asian Alliance for Poverty Eradication (SAAPE), LDC Watch, Asian People's Movement on Debt and Development (APMDD) conducted a consultation for preparedness of government for COP- 28 which was held in Dubai from November 30th to December 12th with the goals of adressing civil society's concern on the issue of climate justice. Jagaran Nepal's Chairperson Samjhana Pokharel, board member Manisha Subedi and staff member Pratistha Subedi participated in consultation workshop. Distinguished people from diverse background ranging from government representatives, climate experts, members of CSOs put forward their opinions regarding climate change and also highlighted some issues that Nepal highlight in COP-28.

Some of the major issues highlighted by the panelists were - Women's agenda also needs to be taken into consideration during COP-28: women who have a significant role in agriculture from production to consumption are at the receiving end of climate crisis. However, the issues of women farmers are not even considered as valid issues and thus have been neglected so far.

Similarly, Nepal contributes 0.027% to greenhouse gas emissions but still is in the 4th place in terms of bearing the impacts caused by the climate change. Nepal being the least responsible but the most vulnerable country from climate change needs to raise its voice strongly in the world stage. Especially in the case of climate finance and loss and damage fund which are crucial to increase Nepal's resilience against climate change. This is a valid ask because Nepal must be compensated for its low emission yet high impact. It was also highlighted that the compensation must reach to the actual vulnerable groups at

the grassroots through direct access of such funds for community as they have a significant role in alleviating climate change impacts.

Likewise, the impact of climate change is slightly higher in mountainous country (due to elevation dependent warming). 1.5-degree centigrade temperature rise in other country means rise of 1.8-degree in mountainous country. Nepal being located in the Himalayan belt, should also raise the concern regarding mountains. The melting of snow is slowly converting mountains into black hills which seriously poses negative impact on sectors like tourism, wildlife, agriculture which are crucial from Nepal's economy. Also, the forum emphasize that concrete efforts should be made to prove that Nepal is indeed one of the most vulnerable countries in terms of climate crisis in the global forum with essential data, facts, figures and statistics to claim for loss and damage fund. In terms of fighting climate change, Nepal role can be by offering clean energy which is becoming abundant in Nepal to replace fossil fuels. So, promotion of the availability of clean energy from Nepal should be prioritized in such international forums. The essence of the discussion was to focus on loss and damage fund and timely compensation for the adaptation, mitigation and resilience.

Digo Bikas Institute on 22nd Novermber, 2023 organized "Women at the forefront of climate crisis in Nepal" discussion session. Jagaran Nepal's staff Ms. Pratistha Subedi participated as a panelist for the discussion. There panelists included in the program were from diverse backgrounds including government representative, member of CSO and young climate activist.

The discussion highlighted the issues for women especially caused due to the climate change, the responsiveness of action against such issues from government side and ways forward in creating genderjust climate solutions from grassroots to the policy level. The representative from government also shared about the government's preparation for COP-28.

The panelists had a common opinion that women, who have a significant contribution in agriculture and other under looked but significant sectors are unfortunately the most vulnerable from climate change. Thus, their voices should be brought into center stage while making climate policies and their participation should often be sought after when hosting such discussions and dialogues.

Conceptual Clarity Training: Fight against Human Trafficking

AATWIN, a network that Jagaran Nepal is a member organization of hosted a 3 days training on "Conceptual clarity against Human Trafficking" from $20^{th} - 23^{rd}$ Novermber, 2023 in Latipur district. Jagaran Nepal's admin and finance officer, Mrs. Sabita Mahat participated in the training session.

The program featured trainers from diverse field including representatives from government agency, lawyer, and representatives from AATWIN. The training focused on learning about the existing mechanism against human trafficking and its effective implementation; legal provision against human trafficking,

situation, challenges and expectations of people affected from human trafficking; major provision taken against human trafficking from the government side and lastly the challenges in mitigation of human trafficking.

It was revealed to us that the government has promulgated progressive laws like the Human Trafficking and Transportation (Control) Act, 2064 and Regulation 2065 against human trafficking but the failure in its implementation has been a significant challenge. Furthermore, the control of human trafficking is not sole responsibility of government only, individual citizens also need to contribute to control it from their side and for this to happen the government needs to protect the whistle blowers. Lastly, since human trafficking is a boarder less and organized crime, collaboration from global and international forums are required in order to effectively control this issue.

Activism Against Gender Based Violence through Art Competition amongst School Children



Jagaran Nepal successfully organized Art Competition on the occasion of the 16 Days of Activism against Gender Based Violence (GBV) among grade 8 students of Central Deaf Higher Secondary School located at Naxal, Kathmandu on 7th December, 2023. The competition was organized under the theme of slogan of 16 Days Activism i.e. "UNITE! INVEST TO PREVENT VIOLENCE AGAINST WOMEN & GIRLS". 22 students participated in the competition with great enthusiasm.

The program was conducted under the chairpersonship of JN's president Mrs. Samjhana Pokharel and in the presence of Mr. Krishna Thapa-President of SMC Federation of Nepal, Mr. Indra Dahal - Education officer of Kathmandu Metropolitan city, Mr. Upendra Parajuli - Principal of Central Deaf School, and board members and staffs of Jagaran Nepal.

Participants stood out for their ability to convey a strong message, provoke thought and exhibit exceptional artistic skill. They successfully translated the theme into the impactful visual representation

that resonated with both judges and viewers. Beyond the competition, the program served as a platform for empowerment and advocacy among deaf students. It demonstrated the potential of art as a tool for their self- expression. The absence of spoken language among the participants was compensated by innovative use of color and symbolism creating a visual narrative.

Ms. Samjhana Pokharel on welcoming remarks extended her best wishes to the participants for the competition and for their future endeavour. She shared the reason behind the celebration of 16 Days of Activism, gave some insight on GBV, its various forms and its impact on individual and society and suggested students to strongly raise their voices against the violence if they ever have to face it.

Mr. Krishna Thapa shared some information regarding GBV and encouraged the students to reveal their creativity. He mentioned that "Participating in this art competition is not just about winning; it's an opportunity to learn, grow, and discover new aspects of your artistic abilities."

Mr. Indra Dahal acknowledging the effort of Jagaran Nepal's team and conveyed a positive and encouraging message for the students. Participation in the 75th International Human Rights Day Rally

NGO Federation of Nepal in collaboration with other CSOs including Jagaran Nepal, on the occasion of 75th International Human Rights Day organized a rally with the theme 'Freedom, Equality and Justice for All' on 10th December, 2024. The rally aimed to commemorate Human Right's Day and advocate for the principles of equality, justice and dignity for all.

The rally commenced with the arrival of Honorable Top Bahadur Rayamajhi - the Chairperson of National Human Rights Commission. Participants from several organization grouped together and marched from Bhrikutimandap to Shantibatika area in Ratnapark, carrying the banners, chanting slogan and engaging with other participants to raise the awareness about human rights issues.

The march provided an opportunity to express our solidarity with the global human rights movement. Banners and placards carried by participants conveyed powerful messages. Several speakers like Krishna Kumari Waiba - chairperson of Beyond Beijing Committee (BBC), Mr. Naren Khatiwada - President at Youth Advocacy Nepal and many more delivered an inspiring speech highlighting the significance of Human Rights Day and the collective responsibility to protect and promote human rights. The highlight of the program was Manisha Shah and her family demanding the justice for her sister Arati Shah's murder. In her speech she added that "The celebration of Human Rights Day has no significance until the innocent people like them gets justice." The event received coverage from media to amplify the message of human rights.

The rally served as a reminder of ongoing human rights challenges, emphasizing the continued importance of raising awareness and promoting accountability.

Numerous panel discussions, workshops, and interactive sessions were held, covering a wide range of topics such as climate change, sustainable development, peace, justice, security, human rights, and political empowerment. WSF-2024 also gave an opportunity for the cultural exchange between the activist of the globe. By fostering this collective action, this forum contributed to the commitment of another world with human rights, unity, dignity, more equality, justice, freedom and security.

As part of World Social Forum – Jagaran Nepal organized/co-organized the following events:

Dialogue on Religious Extremism and Gender Based Violence: South Asian Perspectives

Jagaran Nepal in the collaboration with IMADR Srilanka organized an activity titled "Religious Extremism and Gender Based Violence: South Asian Perspectives" on 16th February, 2024. The discussion aimed to address the intersection of religious extremism and gender-based violence in South Asia, with a specific focus on the Chhaupadi system in Nepal. It sought to explore the root causes, impact, and strategies for combating religiously motivated violence against women, particularly within the context of harmful cultural practices like Chhaupadi in Nepal.

The session was chaired by Ms. Samjhana Pokharel, the chairperson of Jagaran Nepal and was moderated by Women Right Activist Ms. Sharmila Karki. Representative from IMADR, Srilanka Ms. Dharshika Sivapragasam and Ms. Oshara Deemanthi were present in the program. Ms. Dharshika shared her opinion on strategy for a South Asia action plan to foster communal harmony, social cohesion, rule of law and human rights.

This discussion shed a light on the Chhaupadi system prevalent in Nepal, its detrimental effects on women's health and well-being, and strategies to eradicate this harmful practice from society. The program saw participation from various stakeholders including: representatives from various NGOs, students, women rights activist, students, local community leaders.

Highlights from the activity included:

1. Introduction to Chhaupadi practice in Nepal

The discussion began with an overview of the Chhaupadi practice, a deeply rooted tradition in parts of rural Nepal where women are banished from their homes during menstruation and after childbirth. They are forced to live in makeshift huts or cowsheds usually known as chhaugoth, away from their families, due to the belief that menstruating women are impure and bring bad luck.

2. Health Risks and Social Stigma

Participants discussed the severe health risks associated with Chhaupadi, including exposure to extreme weather conditions, vulnerability to animal attacks, and lack of access to proper sanitation and hygiene facilities. Additionally, the social stigma attached to menstruation perpetuates discrimination and undermines the dignity of women.

3. Legal and policy framework

The existing legal and policy framework related to the eradication of Chhaupadi was also discussed. While Nepal's Supreme Court has outlawed Chhaupadi and the government has enacted laws criminalizing the practice, implementation remains a challenge due to deep-rooted cultural beliefs and societal norms.

4. Community Engagement and awareness

Participants emphasized the importance of community engagement and awareness-raising activities to challenge misconceptions surrounding menstruation and promote gender equality. They discussed the need for comprehensive education programs in schools and communities to change attitudes towards menstruation and eliminate harmful practices like Chhaupadi. Participants also indulged in the conversation about the destruction of chhaugoth which was once taken to combat the chhaupadi practice. They came to a conclusion that, destruction of the chhaugoth alone is not the solution to mitigate this social problem. The mitigation of the deeply rooted problem like chhaupadi can only be eradicated by changing the mindset of the people.

The program brought together a diverse group of participants including Member of Parliament, Ex-minister, community leaders, NGO workers, students. The event focused on the significant role of women in promoting global peace and advancing political participation worldwide. It provided a platform to discuss the challenges, achievements, and opportunities for women's engagement in peacebuilding and political leadership at local, national, and international levels.

Speakers for the event were Mr. Prakash Bhattarai, Ms. Satya Pahadi, and Ms. Urmila Thapaliya who highlighted the invaluable contributions of women as agents of peace, emphasizing their unique perspectives, experiences, and approaches to conflict resolution and reconciliation. Participants discussed the barriers women face in accessing political leadership positions and strategies to overcome them, including affirmative action policies, capacity-building programs, and mentorship opportunities. Participants also emphasized the need for global advocacy and solidarity to advance women's rights, peace, and security agendas.

Beyond Beijing Committee (BBC) in collaboration with Jagaran Nepal, FEDO, Women Service Institute and other organizations conducted Women Assembly on Unveiling the voices of multiply marginalized women and girls on 16th February, 2024.

The Women's Assembly on Unveiling the Voices of Multiply Marginalized Women and Girls was convened as a platform to amplify the voices of women and girls who often find themselves at the intersections of multiple forms of marginalization. The program brought together a diverse array of participants, including activists, scholars, policymakers, and grassroots organizations, to engage in dialogue, share experiences, and strategize for meaningful change. This assembly fostered a dialogue and collaboration among stakeholders to address the unique needs and concerns of multiply marginalized women and girls, raised awareness about the intersecting forms of discrimination faced by women and girls from marginalized communities, developed strategies and recommendations for policymakers and practitioners to promote inclusivity and equity for multiply marginalized women and girls. The Women's Assembly on Unveiling the Voices of Multiply Marginalized Women and Girls served as a critical platform for elevating the voices and experiences of those often overlooked or silenced.

By bringing together diverse stakeholders and fostering dialogue and collaboration, the program made significant strides towards promoting inclusivity, equity, and justice for all women and girls, regardless of their intersecting identities. Continued efforts and collective action are essential to translate the insights and recommendations generated by the assembly into tangible change in policies and practices.

Dialogue on Women and Climate Justice

Digo Bikas Institute in collaboration with Jagaran Nepal conducted activity titled "Women and Climate Justice" on 17th February, 2024. The program aimed to explore the intersection of gender and climate change, with a particular focus on the role of women in climate justice initiatives. It sought to raise awareness about the disproportionate impacts of climate change on women and to highlight the leadership and contributions of women in addressing climate-related challenges.

Discussions highlighted the gendered impacts of climate change, emphasizing how women, particularly those in marginalized communities, are disproportionately affected by environmental degradation, natural disasters, and resource scarcity. Participants explored the links between gender inequality, poverty, and climate vulnerability. Participants also discussed the need for gender-sensitive climate financing mechanisms, capacity-building initiatives, and gender-responsive climate governance structures to support women's participation and leadership.

The program served as a platform for dialogue, learning, and action on the critical issue concerning women and climate justice. By amplifying women's voices, showcasing their leadership, and promoting gender-responsive approaches to climate change, participants reaffirmed their commitment to building a more equitable, resilient, and sustainable future for all.

Dimensions and Trends of Human Trafficking: Identification and Responses

Jagaran Nepal shown its participation in the program titled "Dimensions and Trends of Human Trafficking" organized by AATWIN on 16th February, 2024. The program aimed to address the complex dimensions and emerging trends of human trafficking, focusing on effective identification strategies and responses to combat this global crime. It sought to enhance participants' understanding of the multifaceted nature of human trafficking and equip them with the knowledge and skills necessary to identify victims and implement appropriate interventions.

The program provided an overview of human trafficking, including its definition, forms, and prevalence worldwide. Participants discussed the various dimensions of trafficking, including sex trafficking, labor trafficking, and trafficking for organ removal, highlighting the complexities and challenges associated with combating this crime.

The speakers focused on emerging trends in human trafficking, such as the use of technology, social media, and online platforms by traffickers to recruit and exploit victims. Participants explored how globalization, migration patterns, and economic disparities contribute to the vulnerability of individuals to trafficking. The importance of comprehensive legislation, victim-centered approaches, and cross-border cooperation in addressing trafficking and ensuring justice for victims was also discussed.

The program provided a valuable opportunity for participants to deepen their knowledge, share experiences, and enhance their capacity to combat human trafficking effectively. By fostering collaboration and strengthening identification and response mechanisms, participants reaffirmed their commitment to addressing this grave violation of human rights and achieving justice for victims of trafficking.

Sexual Harassment at workplace: Cause and Remedies

Women Security Pressure Group (WSPG) conducted a panel discussion on Sexual Harassment at Workplace on 18th February, 2024. The panelists were from a diverse sector like psychologist, senior advocate and NGO worker. This program was conducted to address the pervasive issue of sexual harassment in professional settings.

Discussions covered the topics like understanding the dynamics of sexual harassment, legal framework and obligations; relevant laws, policies, and reporting mechanisms; impact on victims and bystanders: psychological, emotional, and professional repercussions; prevention and response strategies: training, awareness campaigns, bystander intervention, and support services. Participants had the opportunity to pose questions and share their perspectives.

The panel emphasized the importance of empowering individuals with knowledge and resources to recognize, address, and prevent sexual harassment, while also calling on employers, HR departments, and leadership to prioritize eradication efforts and commit to concrete measures. The event concluded with a call to action for sustained advocacy and collaboration among stakeholders to effect systemic change and promote gender equality in workplaces globally. It empowered individuals with knowledge and resources to combat sexual harassment and advocate for change.



The activity aimed to gather comprehensive feedback from various gender and social groups to inform the development for an inclusive and equitable election bill that has was presented to the parliamentary committee.

The program was chaired by chairperson of Jagaran Nepal - Ms. Samjhana Pokharel. The program was attended by about 100 people including Commissioner of election commission, commissioners of thematic commission, Members of Parliament, women leaders of sister organizations of different political parties, lawyers, journalists, women of social sectors, gender and sexual minorities, person with disabilities and youth. Women from different fields who participated in the program gave numerous suggestions from gender and social perspectives to be incorporated in the proposed election law. It is important to discuss the electoral bill so that policymakers can promote democracy, advance gender equality, and build inclusive societies where all individuals have equal opportunities to participate meaningfully in political processes.

The participants felt that examining election bills through a gender lens is crucial for fostering meaningful representation, identifying and dismantling barriers to women's participation, understanding differential policy impacts, recognizing intersectional dynamics, fostering policy innovation, and upholding human rights. The program successfully gathered valuable insights from various gender and social perspectives, highlighting significant areas for improvement in the integrated election bill. The recommendations generated from the event was presented to the parliamentarians with the goal of promoting a more inclusive, equitable, and accessible electoral process.

People Climate Mobilization 2024: Demanding Global North Countries to PAY UP for Climate Finance

On 21st September, 2024 - Jagaran Nepal was involved in organizing People's Climate March 2024 with the theme "Pay Up for Climate Finance Action". Jagaran Nepal with other civil society organizations, climate activists,

differently-able groups, women, farmers, workers, and indigenous and marginalized groups gathered to demand immediate and decisive action on climate finance to priorities climate justice and equity leading up to COP-29 in Baku.

This action was geared towards drawing the attention of governments and leaders of Global North on the huge overdue bill that they have to pay to the countries of the Global South for their decades of inaction and broken promises when it comes to climate action. Result of their inaction has deepened the gross inequalities and injustices endured by communities, economies, and ecosystems across the Global South. An estimated US\$5 trillion per year is the initial contribution that Global North needs to pay for a much larger debt owed to the Global South as downpayment for a just future.

Jagaran Nepal was part of the organizing committee for this action. The actions held two preparatory meetings leading up to the event in September 13th and 16th. Likewise, an art workshop was held on 19th and 20th September, in order to make the action more vibrant through visual impact materials to effectively deliver the messages of the action. The workshop was focused towards making creative and informative banners, play-cards, message boards and slogans. A day before the event, on 20th September, a press meet was organized which detailed the intention of the action and called upon all citizens to join the People's Climate Mobilization - 2024 demanding countries of the global north to pay up for climate finance in order to combat climate change while delivering climate justice.

On the main event day, around 300 individuals representing various groups including civil society organizations, climate activists, differently-able groups, women, farmers, workers, and indigenous and marginalized communities marched from Jawalakhel to Patan Durbar demanding Global North nations to PAY-UP for Climate Action.

The People's Climate Mobilization 2024 demanded that Climate Finance meet the following principles:

- Climate finance should come from public, not private sources, to avoid profit-driven motives.
- Creation of new and additional climate finance should be prioritized, that go beyond current commitments like overseas development aid (ODA).
- Climate finance should be in the form of grants and not loans, as the Global South is already burdened with debt.
- Climate finance must be adequate, predictable, and timely to address urgent climate action needs.
- Climate finance should cover mitigation, adaptation, loss and damage, and just transition for affected communities.
- Distribution of funds must be transparent, accountable, and aligned with the Global South's priorities.

Peaceful Gathering and Demonstration Program leading up to UN's Summit of the Future Conference

Jagaran Nepal with other civil society organizations, activists and representatives of media were part of a peaceful gathering and demonstration program on 20th September at Maitighar, Kathmandu. The demonstration was organized in the preliminary days leading up-to the "Summit of the Future" convention which was held in New York City, USA, on September 22 and 23.

In light of the upcoming Climate Change Convention (COP-29) that is going to be held in Baku in mid-November 2024, whose decisions have the potential to have a severe impact on the development of small and least-developed countries including Nepal, the demonstration focused at pressuring the decision makers at both national and international levels to decide on favorable policies with regards to climate change and climate finance that support the developing nations of the global south given the current level of climate crisis and its affect that developing countries are facing due climate induced events and disasters. The gathering was held to aware the government representatives to demand decision-makers to favor policies related to climate change that will address the issues of developing countries with regards to climate change so that all countries can have a just and equitable future.

As part of the demonstration, a memorandum was submitted to Minister of Finance, honorable Bishnu Poudel, that listed the demands and appeals of the demonstration.

Jagaran Nepal organized a one-day conceptual clarity workshop on climate change and its surrounding issues for its board members and staff in its office premises on August 27. The resource person for the workshop was Mr. Avishek Shrestha: Director of Climate Justice program at Digo Bikas Institute and Ms. Susmita Baidwar: Climate Justice Program Officer at Digo Bikas Institute.

The workshop covered topics including basics of climate science, climate change movement and its current status, international conventions and frameworks on climate change, Nepal's national plans and policies on combating climate change, orientation on strategies for addressing climate change including mitigation, adaptation and loss and damage, international financing mechanism to combat climate change covering funds such as the Adaptation Fund, Green Climate Fund etc. and the significance of climate justice movement within the climate change movement.

Jagaran Nepal, has been the championing the climate justice movement as we believe that gender justice is only possible when climate justice is taken into account. Thus, the conceptual clarity workshop was hosted in order to capacitate Jagaran Nepal members and staff on issues pertaining to climate change and climate justice movement in order to effectively advocate and lobby for gender friendly climate polices and to develop and execute activities that effectively address the disproportionate burden that climate change has on women.


On August 17th 2024, Beyond Beijing Committee (BBC) organized a conference titled "Beijing +30 National Women's Conference". The conference was organized on the occasion of the 30th anniversary of the Beijing Declaration and Platform for Action (BDPA) issued by the Fourth World Conference on Women in 1995. The conference was held at the Nepal Administrative Training Institute in Jawalakhel, Lalitpur. At the conference, separate workshops were conducted on 14 topics including education, health, economics, climate and the status of women.

Jagaran Nepal is also a Steering Committee member for BBC network. At this conference, Meena Bista, Vice-President of Jagaran Nepal, represented the organization on BBC's Steering Committee and participated in the preparation for the conference. Additionally, the Jagaran Nepal's President, Secretary, and other members contributed their inputs on various workshops under different themes that we organized during the conference. Founder President and Technical Advisor of Jagaran Nepal, Ms. Sharmila Karki chaired and moderated the theme of climate change and agriculture workshop and led the workshop successfully.

As a result of this National Women's Conference, a Kathmandu Declaration was prepared. This declaration will be used as an advocacy document across all levels of government in Nepal. The report will be finally presented to the United Nations' 69th session of the Commission on the Status of Women.


